Good morning! Today is the 55th day of the 60-day regular session of the West Virginia Legislature. This week, we continue tracking the health care-related bills that remain under consideration by the House and Senate. The House introduced 1,108 bills this session, and the Senate introduced 694 bills. Of the 1,802 total bills introduced, we have tracked 364 health care-related bills (20.2%). Of those, 121 bills or 33.2% remain active; the remainder are, for all intents and purposes, now considered dead.

Final Week of Session Will See Flurry of Activity

The activities at the Legislature will accelerate to a record pace this week as the final five days of the regular session count down. Most bills will have to be out of their final committee by Wednesday in order to go through three days of floor readings for final passage by Saturday's midnight *sine die* (final) adjournment.

Currently, there are 121 health-related bills still active. That is nearly 33.2% of the 364 bills we have been tracking since the start of the legislative session. These 121 health bills are profiled in this issue on our active bill status list. In reviewing our bill status, you may notice that bills you've been following are not included in this issue. It could mean they are dead. That is our projection because these did not complete the passage route in their chamber of origin by the 50th day, but does not necessarily mean that a particular bill has been voted down. Make sure to check the active list to determine if a dead bill with the same provisions might have been amended into an active bill.

Interim Legislative Study Resolutions Begin to Surface

As the Legislature enters the final week of its regular session, study resolutions are beginning to emerge. This typically happens when issues considered by the Legislature still contain a number of unanswered questions and more research is necessary, or the issue is very controversial. Accordingly, study resolutions are recommended and such work is carried out during the interim period between legislative sessions.

During that interim period, committees meet for two to three days. Several House and Senate committees originated study resolutions last week dealing with government benefits programs, medicinal marijuana and other topics. These are found listed later in this issue. Next week, we will feature more as they originate and move through the legislative process.

CON Clean-up Bill Action Completed

Legislative action has been completed on **HB 2459**, which transfers the West Virginia Health Care Authority and its functions, including the Certificate of Need program, to the state Department of Health and Human Resources. A five-member board, appointed by the Governor, would be overseen by an executive director, who would report to the DHHR secretary. The board would review and approve (or disapprove) CON applications.

The bill has been characterized as "clean-up" legislation, favored by the HCA and the West Virginia Hospital Association. The bill passed the Senate last week on a 27-6-1 vote, had earlier passed the House on March 6 and will be effective on passage, pending Gov. Jim Justice's signature.

The bill expands upon 2016 legislation to modernize the CON program. It clarifies requirements of the CON process, details expenditure minimums before a CON becomes necessary and exemptions for ambulatory care, and clarifies that telemedicine is not subject to CON review.

It moves the WV Health Information Network to a private, non-profit entity; eliminates financial disclosures filed by hospitals and other health providers; eliminates the annual assessment paid by acute care hospitals to the HCA; increases the cap for CON exemption for CT scanners from \$250,000 to \$750,000; and excludes from CON review acquisition of a "financially distressed" hospital, acquisition of a hospital that is party to a cooperative agreement, and hospital acquisition of a physician practice group that owns an ambulatory surgical center.

The bill also permits academic medical centers with four or more approved medical education programs to enter into cooperative agreements.

A modernization bill passed in 2016 pared down the number of services requiring a CON to 23; raised the capital expenditure threshold, allowing more flexibility for health care providers; reduced CON application fees; exempted telemedicine and other services; and shortened the time frames for CON reviews and decisions. A bundled rules bill (**SB 125**) to fully implement those changes passed the Senate on Feb. 28 and remains pending in the House.

During a series of committee hearings, the WVHA and the WVHCA both urged the Legislature to allow the 2016 bill to reach full implementation. Other legislation that would have done away with both the Health Care Authority and the CON program outright died in committee.

WV Medical Cannabis Act on Amendment Stage in House Today

A bill that would authorize medical cannabis in West Virginia will be on 2nd reading in the House of Delegates today after gaining unexpected momentum last week in the Senate. Having narrowly survived with a 6-5 endorsement from the Senate Health Committee on March 24, **SB 386** headed to the Senate Judiciary Committee and seemed to languish at the end of a lengthy agenda on Tuesday.

However, the bill had been read on the Senate floor for the first time on March 25, and then remanded on 2nd reading to Judiciary. The Judiciary Committee amended the bill, passed it, and brought it again to the floor for immediate consideration on Tuesday. The bill was on 3rd reading on Wednesday – crossover day – the last day it could be considered.

In the meantime, 12 of Judiciary's 17 members also signed on to Senate Concurrent Resolution 50, which urges Congress to reschedule marijuana from a Schedule I drug to an alternative drug schedule, "and to authorize states to regulate marijuana at their own discretion." Schedule I drugs are those with no currently accepted medical use and a high potential for abuse; as such, marijuana currently is considered on a par with heroin, and by extension considered a greater risk than Schedule II drugs such as cocaine, oxycodone, fentanyl and morphine. According to the resolution, reclassification is appropriate, "given the growing domestic and international consensus that marijuana has medicinal value." It also noted that, "marijuana ... has been studied outside the United States for years" and that continued classification as Schedule I prevents the scientific and medical communities from researching its potential.

The full Senate approved the bill late Wednesday on a 28-6 vote, with Sens. Mike Azinger, Donna Boley, Mike Maroney, Dave Sypolt, Tom Takubo and Ryan Weld voting against. On Thursday, the House voted 54-40 (with six not voting) to dispense with any committee reference and immediately consider the bill. On Friday, the House Judiciary chair, Delegate John Shott, successfully asked that 2nd reading be postponed to allow time to craft amendments for consideration today.

The West Virginia Medical Cannabis Act would create a 16-member Medical Cannabis Commission within the state Department of Health and Human Resources. Members would include the DHHR cabinet secretary, Agriculture Commissioner and state Treasurer, or their designees; and 13 members appointed by the governor, including patients, physicians, nurses, pharmacists, scientists, lawyers, law enforcement, an alcoholism and addiction counselor, and someone experience in horticulture. The commission would license as many as 15 growers and 60 dispensaries, and would authorize testing laboratories as well as setting requirements for becoming a "certifying physician." A Medical Cannabis Commission Fund would be created as a special revenue account in the State Treasury.

According to the bill, medical cannabis could be used to treat a chronic or debilitating disease or medical condition that requires hospice or palliative care; or that results in cachexia, anorexia or wasting syndrome; severe or chronic pain; severe nausea; seizures; or severe or persistent muscle spasms.

Substance Abuse Reduction Bill Passes House

The Comprehensive Substance Abuse Reduction Act (**HB 3028**), which creates an Office of Drug Control Policy within the state Department of Health and Human Resources, passed the House of Delegates on a 97-2-1 vote last Monday, and is now headed to the Senate Health and Government Organization committees. The new office would be under the supervision of the State Health Officer.

The role of the office is to serve as a data repository, coordinating information, resources, programs, and state and federal funds through a centralized location. Various public health and education initiatives and pilot programs would be created to prevent and treat substance abuse. The office would develop a strategic plan to reduce the prevalence of drug and alcohol abuse and smoking among both the youth and adult populations by at least 10% by July 1.

The Controlled Substances Monitoring Program would be housed under the state Department of Military Affairs and Public Safety, as called for in a prior bill, and the West Virginia Poison Control Center would remain under the auspices of West Virginia University. The office would report semiannually to the Joint Committee on Health.

The office would also create a plan, by July 1, 2018, to ensure an additional 100 treatment beds are available in privately owned facilities across the state. A DHHR Special Revenue Trust Account would be created to that end, using settlement money from the Boone County civil action against drug distributors, and other public and private sources.

PA Practice Act Changes Await Governor's Signature

A bill that changes language in the Physicians' Assistant Practice Act to reflect a relationship with a "collaborating," rather than "supervising," physician, has passed both houses of the Legislature en route to the Governor. The bill passed the House unanimously on Friday, having earlier been approved by Senate on March 1.

Under **SB 347**, PAs would be allowed to prescribe a monthly supply of Schedule II and Schedule III drugs under certain circumstances, with specified restrictions. PAs also would be granted global signatory authority in a manner identical to advanced practice registered nurses, for death certificates, orders for life-sustaining treatment, orders for scope of treatment and do-not-resuscitate (DNR) orders. The bill also would add a second PA representative to the WV Board of Medicine.

The bill entitles PAs to 100% reimbursement from all public and private insurers, regardless of whether the collaborating physician is in the room when health services are rendered. In addition, "Constant physical presence of the collaborating physician is not required as long as the collaborating physician and physician assistant are, or can be, easily in contact with one another by telecommunication."

Additional new provisions provide that once a PA passes the initial National Commission on Certification of Physicians' Assistants certification exam, they would no longer need to be recertified in order to maintain licensure by the WV Board of Medicine and/or the WV Board of Osteopathic Medicine.

Hopemont Sale Passes House on Narrow Vote

The House of Delegates, in a 51-49 vote Wednesday, approved **HB 3102** to allow Cabinet Secretary Bill Crouch of the state Department of Health and Human Resources to sell Hopemont Hospital and its assets.

Hopemont is a 98-bed licensed Medicaid-certified long-term care facility in Terra Alta, Preston County. The facility currently has 57 patients, with 41 empty beds, and is in need of \$4.56 million in repairs, according to a recent audit. It has 110 employees, plus 73 vacant positions. The bill was originated in the House Health Committee earlier this month. It now moves to the Senate Health and Finance committees.

A similar bill, **HB 2366**, initially authorizes the sale of more than 100 currently vacant beds at Jackie Withrow Hospital in Raleigh County. The bill passed the House on March 24 and also now moves on to the Senate Health and Finance committees. It requires the state to sell the aging long-term care facility, which needs more than \$25 million in repairs. Crouch has said his goal is to sell all four of the state's long-term care hospitals, calling them "time bombs." Jackie Withrow's 108 unoccupied beds (or, technically, the authorization for those beds) would be sold, presumably to private entities. Jackie Withrow is licensed for 199 beds, but currently has just 91 patients.

Under both bills, the state would transfer current patients to area facilities and would develop a strategy to minimize the impact on employees. DHHR would also provide updates to the Joint Committee on Government and Finance, and the Legislative Oversight Commission on Health and Human Resources Accountability.

Nursing Board Bill Dies

Legislation that would have transferred the regulatory authority of the current Board of Examiners of Registered Professional Nurses, the Board of Licensed Practical Nurses, the Medical Imaging and Radiation Therapy Board of Examiners and the Nursing Home Administrators Licensing Board into a new Board of Nursing and Health Services died last week when it was placed on the House Calendar (or inactive calendar) on 3rd reading.

The bill, **HB 3109**, originated in the House Government Organization Committee, would have required an 11-member board, appointed by the Governor. It also would have resurrected provisions of the APRN scope of practice bill enacted in 2016, which included creation of a Joint Advisory Council on Limited Prescriptive Authority. The council, also to be appointed by the governor, has yet to be named and therefore has yet to convene.

In Other Health Care Highlights ...

... Frequent visitors to the House Government Organization committee room (215-East) noticed a change last week to the décor. Gone are the photos of past committee chairs (including good friend and dedicated **HCH** reader Jack Canfield), replaced by vintage black and white photos from the 1930s and '40s of forestry operations, pharmacies and housing construction, courtesy of the West Virginia State Archives. ...

... Two pieces of legislation that pitted personal choice freedoms against sound public policy for all died last week at crossover day. One bill, **SB 537**, would have rolled back West Virginia's immunization standards by allowing religious exemptions from compulsory immunizations for children, as well as students enrolled in colleges, universities and vocational-technical schools; and employees. Currently, the state only allows for medical exemptions. The bill also would have done away with the current review of exemption requests by an immunization officer within the state Bureau for Public Health, relying solely on certification by the individual's personal physician. The bill died when the Senate Health Committee refused to place the bill on its agenda, after it had been approved by the Senate Education Committee. Faithful readers of **HCH** recognize that such legislation crops up every session, even though West Virginia's top ranking for immunizations among school-eligible 5-year-olds is one of the state's few positive health statistics. The other bill, **SB 549**, would have allowed motorcyclists and passengers over 21 to ride without a helmet. Dubbed the "organ donor acceleration bill" by critics, the Senate rejected the legislation by a vote of 15-19 on Wednesday. It was no laughing matter, however. Following its repeal of a motorcycle helmet law in 2012, Michigan found that helmetless riders died in crashes at twice the rate of those who continued to wear helmets. ...
